Introduction and Purpose

This procedure and agreement are designed to support the safe, harmonious, and respectful use of school facilities by Year 12 students who are licensed to drive and wish to utilise the school car park. For any student to be given approval to utilise the school carpark they must hold a current driver's licence applicable to the vehicle they are driving, be using a fully registered vehicle and have it insured for a minimum of third-party property damage (TPPD).

They must have read and fully understand the College Traffic Management Plan which is located on the College website.

Behaviour

Students who drive to school are responsible for their driving and behaviour including that of other occupants of the vehicle. Failure to comply with the school's expectations for conduct by students in the community may be dealt with under the school's disciplinary procedures. Dangerous behaviours may be reported to the police.

Parking

Students must only park in allocated parking bays, not exceed the space of a single parking bay (as indicated by the line markings). Please refer to the Traffic Management Plan to determine bays available for Student Parking.

Transference

Authorisation to utilise the school carpark is not transferrable to other students if the authorised student cannot/is not driving to school. All users must have obtained individual authority from the school to park their vehicle in the school car park.
